NEW BUSINESS

1. CONSIDERATION OF RFP 2018-01 FOR INSURANCE COVERAGE

Mayor Gallegos addressed Council regarding RFP 2018-01 for Insurance Coverage. Clerk Wall stated an RFP for Insurance Coverage executed in 2012 was expiring at the end of this year. Clerk Wall stated because of the amount paid to the vendor, procurement process by RFP was necessary. Jim Lyssy of Insurance Services of New Mexico was present to thank the Village for their past business and would be responding to the RFP. Clerk Wall stated the Council could rescind their earlier decision to contract directly with New Mexico Self Insurer's Fund as there was time to issue an RFP. Clerk Wall stated Procurement Officer Jean Moulton had researched the timeline and stated after further review, there was sufficient time for required publication, evaluation, and award before year's end. 2. CONSIDERATION OF OLD FORT SUMNER MUSEUM ELECTRICAL UPGRADE OUOTE

Mayor and Council discussed a verbal proposal by electrician Jimmy Smith for electrical upgrades to bring the Old Fort Sumner Museum into code compliance. Mr. Smith's verbal quote was between \$4,000 to \$5,500 for upgrades to the exterior electrical connections as they were currently overloaded and not through the roof as electrical code required. Mr. Smith could complete the work on a weekend to avoid delaying the contractor working inside. Mayor Gallegos recommended Council approve the proposed quote for electrical code compliant improvements to the Old Fort Sumner Museum up to \$5,500.

4. BUDGET WORKSHOP #2

Sheriff Harvey stated she still did not have an amount of what the Law Enforcement IGA budget had left in it despite requesting the budget from County Finance office several times. Council stated no decision would be made today.

Mayor and Council also heard a request from DBCRCC Director Linda Boyd, asking for a County suggested increase above the previous year's amount of \$19,000 for the FY 2018-19 E-911 Dispatch IGA. Council stated no decision would be made today.

Library Director Jeni White requested that some funds for plumbing be allocated to deal with the water heater and bathroom plumbing issues in the Library Annex.

Senior Director Patsy Kenyon stated acoustic panels were needed to aid in noise control at the new Senior Center, and additional staff was needed to man the Activity Center so Seniors could still utilize quilting, exercise room, and TV lounge area.
